Faith in Texas has a diverse staff and large base of congregations, clergy, faith leaders and lay leaders across the DFW metroplex. We are purposefully building a multicultural, directly-impacted-led movement with faith and race at the center of our work. Faith in Texas is an affiliate of the Faith in Action network, the nation's largest network developing civic leadership in low- and moderate-income communities.

## **Job Description**

Faith in Texas is seeking a Director of Organizing to join our talented and diverse team. This is a full-time, exempt position based in Dallas, that includes regular evening work and weekend work as needed.

The ideal candidate:

- Is a forward thinking, dynamic change agent who is passionate about justice and wants to dismantle the structural forces causing racial, economic and social disparities.
- Is comfortable working in a multi-racial, interfaith environment.
- Thrives in a fast-paced, team-based atmosphere.
- Is not afraid of a challenge and can effectively problem-solve, multi-task, and make decisions—especially under pressure.
- Is flexible, proactive, and resourceful.
- Is an excellent communicator who maintains a high level of professionalism at all times.

The Director of Organizing is responsible for training, coaching, and managing staff organizers in the execution of a variety of activities including field operations strategies and tactics; congregation organizing and development; deep listening and research support; and expanding volunteer networks. This is a self-motivated position that requires the ability to work with agility on the front lines of the organization as well as the capacity to develop staff and leaders, and cultivate relationships with a diverse volunteer base, clergy, elected officials and other stakeholders. The Director of Organizing reports to the Executive Director and will partner with the ED and other leadership to create and execute organizing and development plans that support the overall strategic goals of Faith in Texas.

## **Responsibilities:**

- Lead training, supervision, coaching and development for staff community organizers.
- Lead collaboration of staff, community leaders, clergy and other allies to develop and implement strategic campaigns that achieve powerful, tangible results for our communities.
- Develop and execute an effective training program for community leaders and clergy.
- Help develop and expand Faith in Texas' strategic partnerships with other community-based organizations and faith groups.
- Lead efforts to build organizational capacity for voter engagement and data-driven work to build and exercise power.
- Work with the Executive Director to manage grant deliverables and cultivate and steward funder/donor relationships to sustain and grow the work.
- Work with the Communications Director to effectively integrate communications strategies into organizing plans to amplify and grow our influence and power.
- Participate in effective, powerful collaboration with other Faith in Action federations in the region and nationwide on national policy campaigns, trainings and cohort work.

#### **Qualifications:**

- At least 5 years of community organizing experience (congregation-based, labor, or other)
- Acute knowledge of legislative process at city, state, and national levels, and the ability to navigate varying political environments
- Successful experience recruiting, training, supervising and developing organizing staff.
- Proven success implementing civic engagement/GOTV campaigns to win tangible results for the community.
- Demonstrated strategic thinking and political analysis skills
- Excellent organizational skills and ability to meet goals and strict deadlines.
- Strong public speaking and writing skills.
- Strong interpersonal and relational skills.
- Proven ability to work effectively with people from diverse racial, cultural, religious and socioeconomic backgrounds.
- Intermediate-to-fluent Spanish strongly preferred.
